

CAMDEN COUNTRY CLUB MEMBERSHIP CATEGORIES

Located in historic Camden, South Carolina's oldest inland city, the Camden Country Club offers the best in southern hospitality and the finest facilities for golf, tennis, swimming, banquets and meetings. Camden Country Club is family-oriented, offering programs to suit each member of your family.

Ross Membership* – Members in this category enjoy voting privileges once the membership fee is paid in full and access to all amenities of the Club (golf facilities, tennis facilities and swimming pool).

Junior Executive Membership* - Offered to members between the ages of 30 and 39. Members of this category have voting privileges once the membership fee is paid in full and access to all amenities of the Club (golf facilities, tennis facilities and swimming pool).

Junior Membership* – Members of this category enjoy full access to all amenities of the Club (golf facilities, tennis facilities and swimming pool). A Junior Member may remain in this category until he or she reaches his or her thirtieth (30th) birthday. On September 16, 2013, the Board of Directors voted to defer the membership fee for Junior Members until they age up. Once a Junior ages up, they are required to pay the membership fee associated with the next membership level. At the age of 29, Juniors may make monthly payments for a one-year period to satisfy the pending membership fee.

Non-Resident Membership* – This membership option is available to individuals who live outside of Kershaw County, South Carolina. Members of this category have full access to all amenities of the Club (golf facilities, tennis facilities and swimming pool).

Sports & Social Membership** – Members of this category have full access to the tennis facilities, swimming pool and driving range. Dependents may play golf, but are not permitted to play in club tournaments. Parents may accompany their child, but are not permitted to play. Please contact the Pro Shop for more information and restrictions.

Military Appreciation: The club offers a 50% membership fee discount for active or retired military. A copy of valid Military I.D. required. *Approved by board August 2017.*

* Ross, Junior Executive, Junior and Non-Resident members make may annual or semi-annual dues payments. Quarterly and monthly dues payments are permitted via bank draft or credit card draft only. Draft authorization forms are available upon request. Please note members are responsible for any applicable membership fees and/or difference in membership fees upon change in membership status. A three (3%) service fee is applied to credit card transactions.

** Sports & Social Members may make monthly payments from January 1st – June 1st via bank draft or credit card draft only. Draft authorization forms are available upon request. A three (3%) service fee is applied to credit card transactions. Otherwise, dues are due in full by January 1st or at the time of board approval. Please note members are responsible for any applicable membership fees and/or difference in membership fees upon change in membership status.
